**Qualifying Products:**

**All insurance plans written through AIMC, LLC for the following companies:**

- Royal Neighbors of America
- Central States Indemnity Co. of Omaha
- PLUS Future Releases

**Qualifying Production:**

- Producer: 150 Production Points
- Agencies: 500 Production Points = 1 staff member slot
- Distribution Partner:
  - 1300 Production Points = 1 staff member slot
  - 2000 Production Points = 2 staff member slots
  - 2750 Production Points = 3 staff member slots
  - 3350 Production Points = 4 staff member slots

**Production Points:**

- Medicare Supplement = 1 point
- Sterling Investors Whole Life (only 1 app per insured) = 1 point
- Sterling Investors Convalescent Care = 1 point
- Family Life Secure Care = 1 point

**Rules:**

- All policies must be issued by March 15, 2012
- Agents can only qualify for one category of the three: Producer, Agency or DP
- Adult-only convention. Only the qualifying agent and guest 18 and older may attend (non-assignable, non-transferable).
