2015 AHIP certification now available, followed by UnitedHealthcare certification July 1

UnitedHealthcare Medicare Solutions is accepting America's Health Insurance Plans (AHIP) certification and AHIP re-certification in place of:

- 2015 Medicare Basics
- 2015 Medicare Advantage Plans
- 2015 Medicare Part D Plans (Prescription Drug Plans)

UnitedHealthcare will accept either a new AHIP certification or a re-certification if you are a returning AHIP user. Returning users will be directed to specific re-certification modules upon accessing their AHIP account. Please note: AHIP allows users more than three attempts to receive a passing score. However, UnitedHealthcare will only accept AHIP credit if you obtain a passing score in three or less attempts.

AHIP Certification Options

1. **Beginning today you can take 2015 AHIP courses directly from the [AHIP website](#).** However, you will need to return to the Learning Center on the UnitedHealthcare Distribution Portal after the certifications have launched on July 1 or after to transfer credits to UnitedHealthcare for the 2015 certification year. In addition, those that certify with AHIP will need to complete additional prerequisites (2015 Ethics & Compliance and 2015 AARP 101) to become fully certified to sell with UnitedHealthcare. 2. **You may also access the AHIP courses from the Learning Center on the UnitedHealthcare Distribution Portal, beginning on July 1, 2014.** If you access the Learning Center on or after July 1, you will be eligible for a \$50 discount on AHIP courses offered by UnitedHealthcare.

This discount will be automatically applied upon payment.

If you do choose to take the AHIP courses, UnitedHealthcare encourages you to also take the time to review the 2015 UnitedHealthcare Medicare Basics course to assure you are fully prepared for the 2015 selling season.
